

**DNR Seeks Comments  
on Kelliher ATV Trail Project**

The Minnesota DNR invites the public to review and comment on a proposal by the city of Kelliher to obtain Grant-in-Aid funding for an all-terrain vehicle trail in Beltrami County.

The off-highway vehicle (OHV) Grant-in-Aid program is a partnership between the DNR, a local government sponsor and an OHV organization to provide funding for trail development and maintenance.

The trail, known as the Kelliher ATV Trail, would provide approximately

trails like Johnson Lake/Franklin Lake/Maude Lake/Astrid Lake/Long Lake ATV Access Trails on the LaCroix District as well as Sturgeon River Trails and the Deepwater Lake ATV Access Trail on the Laurentian District are included in the proposal. **USDA Forest Service Invites  
Public Feedback on Proposed  
List of Deferred Maintenance  
Projects for Fiscal Year 2022**

Milwaukee, WI (November 20, 2020) – The USDA Forest Service Eastern Region is seeking public feedback on a proposed list of deferred maintenance projects selected for Great American Outdoors Act funding in fiscal year 2022.

The Eastern Region’s project list can be found on the Eastern Region Great American Outdoors Act Projects webpage. These projects aim to address the agency’s \$5.2 billion deferred maintenance backlog and improve public access and quality of visitor experience through repair and restoration of roads, trails, bridges, recreation sites, and other facilities. The proposed projects were selected based on seven criteria:

- Reducing deferred maintenance
- Promoting management of America’s forests
- Improving visitor experience
- Contributing to rural economic development

**Supporting Facts You Can Use In Your Comment:**

-This proposed 98.8 mile ATV trail system is an important addition to the ATV trail system in northwestern Minnesota.

-This route will connect Waskish and Kelliher to the Blue Ox State Trail, as well as to Blackduck and Bemidji and northeast up to International Falls.

-This route will connect the Blue Ox State Trail system to the south shore of Red Lake and provide important business and service connections.

-While much of this trail system will use public roads, because of the wetlands, private lands and tribal lands in this area, few other options exist.

-This new ATV Grant-in-Aid system will help move us closer to being able to connect the different regions of the

“We want to hear from our visitors and stakeholders about what matters most to them and what they think is needed to improve their experience,” said Gina Owens, Eastern Regional Forester. “This effort to improve our infrastructure is the largest investment in a generation, and we want to make sure we wisely use it to meet our visitor’s needs and modernize our offerings.”

Signed into law this summer, the Great American Outdoors Act provides funding that will enable federal land managers to take aggressive steps to address deferred maintenance and other infrastructure projects on national forest and grasslands through 2025.

The Forest Service is working closely with all interested publics to ensure the selected projects continue to meet local needs and maximize the benefits experienced by millions of Americans who visit and use their national forests and grasslands.



**DNR seeks comments on environmental assessment worksheet for proposed Voyageur Country ATV System project**

The Minnesota Department of Natural Resources is accepting public comments through Dec. 16 on an Environmental Assessment Worksheet (EAW) for a proposal to expand and improve the Voyageur Country All-Terrain Vehicle System in northern St. Louis County.

**The Voyageur Country ATV club is proposing to include 386.51 miles of paved, gravel, and native soil roadway and natural surface trail for motorized ATV use in its trail system.** The trail system would connect several communities by adding 2.54 miles of newly constructed trails, designating and improving 69.83 miles of existing trail to allow for ATV use, and connecting to 314.14 miles of existing trails.

The EAW is available on a project page of the Minnesota DNR website. (*Editor's note: Do an internet search for "MN DNR OHV Voyageur Project."*) A copy of the EAW may be requested by calling 651-259-5115. The DNR is accepting written comments on the EAW through 4:30 p.m. on Wednesday, Dec. 16. Comments should be submitted to the attention of Cynthia Novak-Krebs, project manager, Environmental Policy and Review Unit, DNR Ecological and Water Resources Division, 500 Lafayette Road, St. Paul, MN 55155-4025.
