December 3, 2022 Grand Casino Hinckley ATV Minnesota Legislative Summit

It is important for ATV Minnesota, its members and member clubs to have a collective voice, communicated through our lobbyists to the State Legislature, to form laws and direct funding that create a positive future for ATV recreation in Minnesota. That process starts with the ATV MN Legislative Summit.

Plan now for your ATV club to be represented at this important meeting, either in person or on Zoom, December 3, 2022, 8am to noon, at Grand Casino Hinckley. We will have continental breakfast available in the room during the meeting.

This is your ATV club's opportunity to submit resolutions to be prioritized and voted on, giving ATV Minnesota and its lobbyists direction and priority on what Legislative issues will be pursued during the 2023 Legislative Session.

All ATV Minnesota member clubs are invited to send representatives; each club gets one vote on resolutions and issues. The resolution form, details and deadline have been emailed to club representatives of all ATV MN member clubs. Because nothing was passed by the Legislature during the last Session, all existing Resolutions from last year remain active and do not need to be resubmitted unless you need to make a change to that request. If the existing Resolution remains unchanged you do not need to do anything with it.

We need all new Resolutions into the ATV MN office on or before Friday, November 25th, 2022. That is Thanksgiving weekend so if that is a problem meeting that deadline please contact the ATV MN office.



Previous Resolutions Are Still Active

At our last Legislative Summit, held January 8, 2022, 50 ATV club representatives, association lobbyists, county commissioners, ATV manufacturer representatives, and DNR Parks & Trails partners attended.

Resolutions discussed and voted on as high priorities for ATV MN and its member clubs included:

- To continue working to remove “low pressure or non-pneumatic (tires),” and increase the maximum weight from 2,000 lbs to 3,000 lbs for the ATV definition in State statutes.
- To approve allocating funds from the ATV Dedicated Account or through bonding to expand trail systems of the Roseau & Lake Of The Woods Sportsmans Club, the Prospector Alliance, and Voyageur Country ATV.

Resolutions discussed and voted on as secondary priorities:

- To support legislation to open to ATVs some sections of state highways in communities in order to connect trails to services.
- To support the ability of 16-17 year old riders who have their DNR certification to ride with a passenger, when riding with parents and having a drivers license.
- To support non-profit ATV clubs receive a sales tax exemption on all equipment and attachments as an allowable cost in the GIA manual.

Resolutions discussed and voted on as thirdly priorities:

- To support removing the Ag Zone Restriction, which currently restricts the ability to operate in the ditches in the southern part of the State until after August 1.
- To support providing for a reduction in the ATV registration fee for those who belong to an ATV club.
- To support an opt-in option to receive information about ATV MN when registering ATVs.



A few other resolutions presented by ATV clubs were discussed and tabled at that time because they were issues related to DNR policy and did not require action at the Legislative level.

Upon adjournment of the Legislative Summit, the current and new priority resolutions will be reviewed by the Executive Board and, upon approval, will then be in the hands of ATV MN lobbyists Ray Bohn and Tom Hackbarth, who will move them forward at the State Capitol. The bills require sponsors within the Legislature, and go through many steps in the hope of becoming law.

November 30th: Grant-in-Aid Applications And Sign Orders Are Due

As stated in the DNR grant manual:

"Trail Funding Application Process: Each year grant funding applications for trails and riding areas already in the program must be submitted by the sponsor to the Area Parks and Trails office by November 30 or as stated on the DNR OHV GIA website. New trail proposals may be submitted at any time."

Grant-in-Aid (GIA) funds are available to help develop and maintain recreational

trails for use by all-terrain vehicles, off-highway motorcycles and off-road vehicles.

First authorized in 1984, the GIA program provides cost-sharing opportunities at the initiative of clubs and other organizations, with the support and participation of local government sponsors. Organizations can apply for GIA funds through counties, cities or townships. All aspects of OHV trail development and maintenance are eligible for funding, including project administration, site planning, trail improvements, land acquisition for trail development, and trail maintenance. Proposals with a focus on maintaining or improving existing trails and trail systems will be assigned a higher priority.

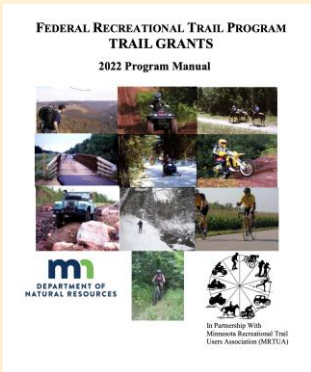

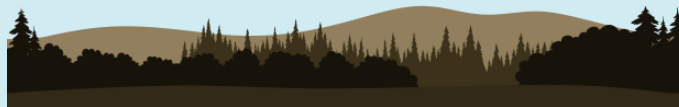
